WWQQ'S "JORDAN DAVIS FACEBOOK" CONTEST OFFICIAL RULES

The Station will conduct the JORDAN DAVIS FACEBOOK Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. **Contest Period.** The Contest entry period will begin at 11:00AM ET on Oct 9, 2023 and will run through 11:00 AM ET on Oct 13, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- **3. How to Enter.** Entrants must:
 - (a) Visit the Station's Facebook page at www.facebook.com/DoubleQ101 during the Contest Period;
 - (b) Like, Comment, and Share the Jordan Davis post and
 - (c) Include in the comment: #contest.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

4. Winner Selection.

On or about 12PM ET on Oct 13, 2023, Station will select 1 potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. - 7. Entry Conditions and Release. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
